This meeting will also be setting out the debate by way of round-table discussions: "Online Gaming and the Gaming Sectors", moderated by Mr. Rafael Catalá Polo, the CODERE General Secretary, in which the industry's main associations will be taking part; and "Synergies & Alliances: Public Commitments" moderated by Ms. María Ángeles González García, the General Technical Secretary from the Spanish Ministry of the Interior, which will be attended by representatives from the Administrations of the Autonomous Communities of Valencia, the Basque Country, Madrid, Catalonia and La Rioja.
